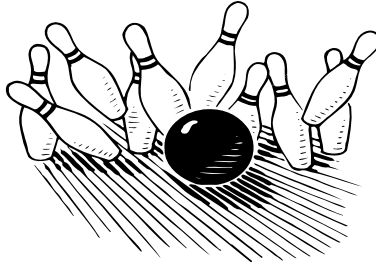

You further agree that in the event circumstances beyond control of the Greater Southern California Council shall arise before or during the scheduled tournament, thereby causing a cancellation, postponement or suspension of the tournament, in part or in its entirety, the Greater Southern California Council shall not be held liable for the payment of cash prizes or other prize winning awards. Entrants having already bowled will be refunded that portion of the fee allocated to the prize fund. Entrants not having bowled will be refunded the prize fund and bowling fees.

ENTRY FEE: \$35.00

All Prize Money Will Be Based On Total Pins Plus Handicap 100% Of 220.

100% Return of Prize Fund - Based On a Minimum Ratio of 1 for Each 6 Entries.

In Lieu of Prize Fund Youth Bowlers Will Receive Scholarships through the USBC Smart Program.

All Entrants Must Be Members in Good Standing with USBC, their Local Association and the California USBC.

Check In 1/2 Hour Prior To Time To Bowl.

Bowlers Will Be Required To Show Their USBC CERTIFICATION Card, or current receipt.

Entrants Will Bowl 4 Games within their individual Division: Men or Women, Boys or Girls.

Optional Brackets Will Be Offered For the First 3 Games Only.

All Bracket Entries will be handicapped with the same handicap used for tournament.

Youth will have the option to sign a USBC Prize Waiver for brackets.

Entering averages to be used will be in the order given based on 21 games or more.

- **Official Book Average 2009-10, if none then use:**
- **Final Summer for 2009 with 21 games or more
(average verification required signed by local association manager).**
- **If none of the above bowlers shall be assigned a 220 average.**

USBC Rule 319a-e Will Be In Effect. Rule 319-f Will Be Waived.

The Official Dress Code will be STRICTLY ENFORCED. Information will be sent with entry confirmation.
