TOURNAMENT RULES - PLEASE READ CAREFULLY

ENTRY CLOSING DATE: March 24, 2010. Late entries will be accepted up to 1 hour of squad time if lanes are available. Late entries are subject to a \$25 late fee per entry. Late fees will be added to the prize fund.

ELIGIBILITY: This is a team, singles, doubles, and all events tournament open to all Citrus Belt USBC members. Non-members must purchase a paid in other association card. Bowlers may compete twice in each event with special conditions (see "Multiple Participation" section below). No more than two (2) current PBA cardholders per four-person team or one (1) per two-person team will be permitted.

ENTRY FEE: \$18.00 per person per event with optional Handicap All Events \$6.00 and/or optional Scratch All Events \$10.00. Remit by money order or check made payable to CBUSBC Association. Fees are not refundable after definite dates have been assigned or if it is discovered that some team or entrant failed to comply with USBC eligibility requirements. The Tournament manager may refuse to permit any team or entrant to bowl if it is determined the entry should not have been accepted.

HANDICAP: Handicap shall be; Singles 80 % of the difference of entrants entering average and 225. Team, 80% of 900, Doubles, 80% of 450, Handicap All-events 80% of 225 times 3

ENTERING AVERAGE: Use the averages in the order given below as applicable to each bowler. It shall be the bowler's responsibility to insure the submitted average is correct and/or a corrected average is used at the time of competition.

1. Highest 08/09 Citrus Belt Book
2. Citrus Belt Summer 2009 (21 games) if no book
3. Highest Citrus Belt Current average of 21 games as of closing entry date
4. Highest 2007/2008 Citrus Belt Book
5. If none of the above, bowler will use 225

YOUTH averages will not be accepted

USBC Rule 319-a2, c, d, e do not apply

MULTIPLE PARTICIPATION: Bowlers are eligible to compete twice-**Team**, no more than 2 of the same bowlers per team. **Doubles** must be with a different partner. Bowlers may cash in singles more than once if multiple entry.

ALL EVENTS (Handicap and/or Scratch): A one-time entry to either or both of the all events is optional. Entrants must bowl in the team, doubles, and singles events (9 games) to be eligible for all events and their first appearance in each event shall count towards their all events scores. All-events is not transferable unless the substitute replaces the original entrant in all three events.

SUBSTITUTES: Averages will follow the same as all other entrants. Substitutions should be made in the Tournament Office by the Team Captain or designated representative at least one hour prior to the scheduled time of bowling.

CHECK-IN: All individuals as well as team captains must report to check in (30) minutes prior to scheduled bowling time,

BOWLING ATTIRE: Participants are requested to wear garments in good taste, appropriate for tournament bowling. **NO** tank tops, spaghetti straps, short shorts, or bare midriffs. Skirts and skorts must be knee length or longer.

ABSENT OR LATE PLAYERS: Any player arriving late shall begin play at the point of game in which tournament is in, shall receive a zero (0) for any missed frames. Absentee scores shall be 0 for the game.

USBC AWARDS: Scores bowled shall qualify for USBC awards as outlined in Chapter VI of the USBC 2009/10 Playing Rules Book.

ADDED MONIES: As stated in the merger agreement, and allowed by USBC Tournament Rule 308, these added monies will be presented to the 1st place winners after determination of prize fund allocations as shown otherwise in these rules.

1st Place Team \$800.00, Doubles \$150.00, Singles \$75.00, All Events, Hdcp. and Scr., \$75.00 each div

EQUIPMENT: Once your squad has started, there shall be no altering the surface of bowling balls, no foreign substance to be used on shoes. Participants must be aware of USBC specifications regarding the hardness of bowling ball.

USBC RULES: This is a USBC certified tournament will be governed by USBC rules even if not specified in this entry

TRANSFER OF DATES OR LANES: When the Association Manager or authorized assistant deems it necessary and (if it is possible) entrants may be transferred to a different date or lane.

* note - No one other than tournament bowlers or those working the tournament are allowed in the bowlers area.

Premature termination of the tournament brought about by war, national emergency, or emergency causes relating thereto or there from, fire, natural disaster or any other reason beyond the control of the Citrus Belt USBC tournament shall cause, to the extent required there by all advertised prizes, guaranteed or otherwise to be prorated in accordance with the number of entrants who have bowled in each of the respective events up to the time of such termination.
